

2019 AWARDS PROGRAM

Purpose

- To recognize a member for extraordinary professional or significant volunteer contribution to the profession, OR
- To honour a person who is not a member for contribution to planning (Friend of Planning award).

Eligibility

All members in the Institute are eligible for the Exceptional Service award, except current MPPPI Council members. Previous recipients of an award can be nominated more than once provided that the nomination is for a different set of circumstances than that established for any previous award.

Selection Criteria

- Contribution to the profession through their innovative and cutting edge practice by implementing unique approaches to community planning or land development.
- Contribution to the profession through their volunteer efforts.
- A non-planner who has contributed to the profession through volunteer service or has raised the profile of the profession in a positive way.

Members must be in good standing with the Institute to be eligible for member awards.

Selection

An MPPPI Awards Selection Committee appointed by MPPPI Council will consider nominations and make the selections. MPPPI reserves the right to not issue any awards in a particular category for any given year.

Nomination

Nominations at large may be submitted in writing signed by two members in good standing (other than the nominee).

Presentation

Awards will be presented at the 2019 Manitoba Planning Conference (May 15-17) in Brandon. The recipients will be acknowledged on the MPPPI website.
